ORDER

1. The Principal, DM WIMS College of Pharmacy vide paper read (1) above, had applied for provisional affiliation of B Pharm course.

2. The application was processed by the University and the report of the inspection Commission was scrutinized by the scrutiny committee and as per report of the committee consent of affiliation was granted for starting B Pharm course with annual intake of 60 seats subject to the condition that re inspection is to be conducted in the college before granting provisional affiliation.

3. As per paper read (4) above, the Pharmacy Council of India has granted approval for starting of B Pharm course with annual intake of 60 (sixty) seats at DM WIMS College of Pharmacy during the year 2016-17, subject to appointment of teaching staff. The Hon'ble High Court of Kerala in W.P (c) No. 22519 of 2016 has issued orders directing the AICTE to grant the permission sought by the petitioner for establishing the Pharmacy college forthwith to enable the petitioner to commence the courses applied for during the current academic year itself.

4. The Principal, DM WIMS College of Pharmacy has remitted an amount of Rs. 3,00,000/- (Rupees Three lakh only) towards the Provisional affiliation fee and Rs. 7,50,000/- (Rupees Seven lakh fifty thousand only) towards Refundable Deposit for starting of B Pharm course as per order read (4) above and has submitted an undertaking in Kerala Stamp paper agreeing to abide by the rules and regulations of the University.

3. After considering the matter in detail, sanction has been accorded by the Vice Chancellor by exercising the powers conferred under Section 12(7) of Kerala University of Health Sciences Act, 2010 to grant provisional affiliation to DM WIMS College of Pharmacy for starting B Pharm course with annual intake of 60 seats during the academic year 2016-17, subject to report of the re inspection commission, ratification of the Governing Council and as per conditions detailed below: -

1. Selection, Admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.

2. The college should submit approval from AICTE for starting the course on or before 20/08/2016.

3. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.

4. Affiliation granted is strictly provisional and only for the academic year 2016-17. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

5. Admission to the next academic year shall be made only after obtaining prior permission from the University.

6. The College should remit Annual Administration fee of @ Rs. 1250/- per student (Rupees One thousand two hundred and fifty only) after closure of admission for the academic year 2016-17.

7. The College should collect fees** from the students to be remitted to the University as follows: -


