ORDER

As per paper read (1) above, the University had invited applications for continuation of provisional affiliation for the academic year 2017-18 from colleges for courses affiliated to this University. The Principal, DM WIMS College Of Pharmacy-MP041 has submitted application for the continuation of provisional affiliation for the course B Pharm with an intake of 60 seats vide paper read (2) above with requisite fee.

Pursuant to the application an inspection commission was constituted. On verifying the inspection report, initially the scrutiny committee recommended not to grant continuation of provisional affiliation, citing the reason that the conduct of the course at the college was not approved by AICTE. Later vide paper read 3 above the scrutiny committee opined that there is a court order, directing the AICTE to grant approval to the course, conducted at the college and recommended to grant continuation of provisional affiliation to the college.

The Governing Council in its 39th meeting held on 12.06.2017 vide paper read (3) above had decided to grant continuation of provisional affiliation for the year 2017-18 to the colleges to which the scrutiny committee has recommended to grant continuation of provisional affiliation and on receipt of the renewal permission from the concerned apex council. DM WIMS College of Pharmacy, Wayanad comes under the purview of the above decision. Now the college has got approval from the apex council vide reference 5 and 6 above.

Sanction has therefore been accorded by the Hon'ble Vice Chancellor implementing the decision No 39.23 of the 39th Governing Council to grant continuation of provisional affiliation for the year 2017-18 to DM WIMS College of pharmacy, Wayanad for conducting B.Pharm course with an intake of 50 students subject to the following conditions.

- 1 Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- 3 Affiliation granted is strictly provisional and only for the academic year 2017-18. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- 4 The College should remit annual administration fee fixed for UG course for the academic year 2017-18
- 5 Admission to the next academic year shall be made only after obtaining prior permission from the University.
