KUHS - Academic - Pharmacy - Granting of Continuation of Provisional Affiliation to 6 Pharmacy colleges for the Academic year 2021-22 - Decision of the Governing Council - implemented - Orders issued

### ORDER

1. University vide read (1) above invited applications for Continuation of Provisional Affiliation for the Academic year 2021-22 from colleges for courses affiliated to this University. The Principals of Pharmacy Colleges mentioned in para (4) below have submitted application and remitted required fee for Continuation of Provisional Affiliation for the year 2021-22.
2. Applications were processed by the University and inspections were conducted at the Colleges. The reports submitted by the Inspection Commission were verified by the Scrutiny Committee and the Scrutiny Committee recommended to grant Continuation of Provisional Affiliation to the Colleges mentioned in the table below for the Year 2021-22.
3. The Governing Council vide paper read (2) above decided to grant Continuation of Provisional Affiliation to the Pharmacy Colleges mentioned in para (4) below for the Academic year 2021-22, with courses and intake mentioned against each, based on recommendations of Scrutiny Committee, subject to receipt of renewal permission from PCI. Now, all the Colleges mentioned at para(4) below have submitted renewal permission from PCI for the Academic Year 2021-22. The Colleges have constituted College Council as stipulated in Chapter XXI of First Statutes of the University.
4. In these circumstances, Continuation of Provisional Affiliation is granted to the following Pharmacy colleges for conducting the courses with annual intake of students specified against each during the academic Year 2021-22 as detailed below.

4.	Mount Zion College of Pharmaceutical Sciences & Research, Chayalode P O, Adoor	B.Pharm- 60
5.	Prime College of Pharmacy, PrimeNagar, Kodumbu Post, Palakkad	B.Pharm - 60 M.Pharm Pharmaceutics - 15
6.	Nirmala College of Pharmacy, Ernakulam	B.Pharm - 100 PharmD - 30 M.Pharm Pharmaceutics - 15

5. The Colleges shall strictly adhere to the general conditions detailed below:-

i) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.

ii) In the light of the direction of the Supreme Court of India in Writ Petition(c)56/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.

iii) Affiliation granted is strictly provisional and only for the academic year 2021-22. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

iv) The Colleges should remit annual administration fee fixed for UG/PG courses for the academic year 2021-22.

v) Admission to the next academic year shall be made only after obtaining prior permission from the University.
