## <u>O R D E R</u>

University, vide notification read (1) above, had invited applications for starting additional courses/enhancement of seats for the academic year 2021–2022. The colleges mentioned in para (4) below have submitted application for starting of new courses / enhancement of seats for the academic year 2021–22. University conducted inspection in these colleges to assess the facilities for the conduct of the Pharmacy courses. Inspection teams conducted inspections and submitted their reports.

2. On scrutiny of the inspection reports the scrutiny committee and the Subcommittee of Governing Council recommended for starting of new Pharmacy courses / enhancement of seats in existing courses in the colleges. All the said colleges are having permission from the PCI for the conduct of the courses mentioned below for the year 2021–22. The colleges paid the required fee for provisional affiliation and fee for refundable deposit.

3. Governing council vide read (2) above, had resolved to grant Provisional Affiliation for the academic year 2021–22, to the colleges listed as per the table below to start new courses / enhancement of seats, based on the recommendations of Scrutiny Committee, SubCommittee of Governing Council and approval of Pharmacy Council of India.

4. In the circumstances Provisional Affiliation is granted to these colleges for starting new courses/ Enhancement of seats in existing courses with the intake mentioned against the name of each college during the year 2021–22.

5. The colleges shall strictly adhere to the conditions detailed below:-

i) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.

ii) In the light of the direction of the Supreme Court of India in WP(C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.

iii) Affiliation granted is strictly provisional and only for the academic year 2021–22. The College has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

iv) Admission to the next academic year shall be made only after obtaining prior permission from the University.

v) College has to remit annual administration fee fixed for UG/PG Courses during 2021–22.

vi) College shall collect fees (One time payment at the time of admission) from the students to be remitted to the University as follows (College is bound to remit the fees prescribed by the university from time to time).
