ORDER

As per paper read (1) above, applications were invited for Continuation of Provisional Affiliation for the academic year 2018-19 from colleges for courses affiliated to the University. The Principal, DM WIMS College of Pharmacy, Meppadi. P.O, Wayanad vide paper read (2) above had submitted application for the continuation of provisional affiliation.

- 2. Pursuant to the verification of the application submitted, Inspection Commission was constituted and the report submitted by the inspection commission was scrutinized by the Scrutiny Committee. On verifying the Inspection report, the scrutiny committee vide paper read(3) above observed that DM WIMS College of Pharmacy, Meppadi P O, Wayanad has all the required facilities like infrastructure, faculty, equipment, library, land and recommended to grant Continuation of Provisional Affiliation to the college for the academic year 2018-19.
- 3. The Governing Council vide paper read (4) above decided to grant Continuation of Provisional Affiliation to DM WIMS College of Pharmacy, Meppadi P O, Wayanad to conduct B. Pharm course with 50 seats during the year 2018-19, based on recommendations of scrutiny committee subject to receipt of renewal permission from AICTE and PCI . Now the college has submitted renewal permission from the apex councils vide paper read (5) & (6) above and has remitted the requisite fee.
- 4. Sanction, has therefore been accorded by the Vice-Chancellor by implementing the decision of Governing Council vide paper read (4) above, to grant continuation of provisional affiliation to **DM WIMS College of Pharmacy, Meppadi P O,Wayanad for conducting the B.Pharm course with a student intake of 50 seats** during the academic year 2018-19 subject to the conditions detailed below:-
- i. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.

- ii. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- iii. Affiliation granted is strictly provisional and only for the academic year 2018-19. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- iv. The College should remit annual administration fee fixed for UG course for the academic year 2018-19.
- v. Admission to the next academic year shall be made only after obtaining prior permission from the University.
